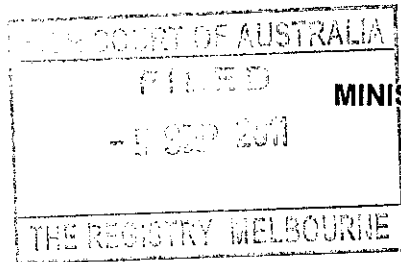

Between 5 Dec 1991 and 6 Sep 1992 <sup>1</sup>	Plaintiff is born in Afghanistan.	10 [1], 12 [15]
On or about 18 May 2009	Plaintiff arrives in Australia at Christmas Island without a valid visa.	10 [2]
14 Sep 2009	Plaintiff applies for a Protection (Class XA) visa.	10 [3]
Prior to 16 Sep 2009	Relationship between the Plaintiff and his mother is declared to the Department of Immigration and Citizenship.	11 [8]

16 Sep 2009	Respondent grants a Protection (Class XA) visa to the Plaintiff.	10 [3], 56
4 Dec 2009	Plaintiff's mother applies for a Refugee and Humanitarian (Class XB) visa.  Plaintiff proposes his mother's application.  (Plaintiff is under 18 years of age.)	10 [4], 21-46  12 [12], 47-56  12 [15 (a)]
7 Sep 2010	A delegate of the Respondent decides to refuse the Plaintiff's mother application for a Refugee and Humanitarian (Class XB) visa.  (Plaintiff is over 18 years of age.)	12 [14]  12 [15 (b)]
7 Dec 2010	The delegate writes to the Plaintiff's mother advising her that her application for a Refugee and Humanitarian (Class XB) visa has been refused.	12 [16]
28 Dec 2010	The delegate re-notifies the Plaintiff of the decision to refuse the grant of a Refugee and Humanitarian (Class XB) visa to the Plaintiff's mother.	12 [17], 67-71
27 Jan 2011	Plaintiff files in the High Court of Australia an application for an order to show cause.	13 [19]
15 Jun 2011	Plaintiff files an amended application for an order to show cause.	1-8, 13 [20]
15 Jun 2011	Justice Crennan refers the special case to the Full Court for hearing.	9
