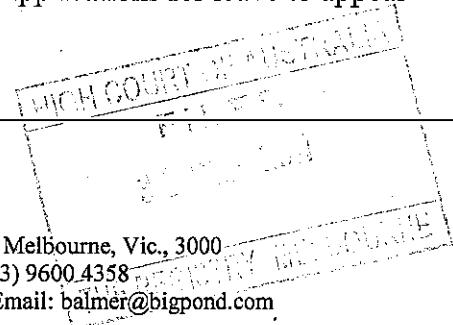

**PART II: CHRONOLOGY OF PRINCIPAL EVENTS**

- 20 13 July 2005 Motor vehicle collision occurs. Two passengers in appellant's vehicle killed.
- 3 March 2006 Appellant interviewed by police.
- 1 September 2008 Appellant pleads not guilty to two counts of culpable driving causing death and his trial commences in the County Court at Melbourne.
- 10 September 2008 Appellant found guilty of culpable driving causing death (two counts) and taken into custody.
- 30 30 October 2008 Appellant sentenced to seven years and six months' imprisonment with a non-parole period of four years and six months, with 51 days of pre-sentence detention declared.
- 7 November 2008 Appellant's solicitors file applications for leave to appeal against conviction and sentence.
- 9 February 2011 Court of Appeal hears appellant's applications for leave to appeal against conviction and sentence.




- 17 March 2011 Court of Appeal delivers judgment. Application for leave to appeal against conviction refused. Application for leave to appeal against sentence allowed. Appellant re-sentenced to six years and six months' imprisonment with a non-parole period of three years and six months.
- 15 April 2011 Application for special leave to appeal (against order refusing application for leave to appeal against conviction) filed.
- 10 2 September 2011 Application for special leave to appeal (and application to extend time) heard by Gummow and Bell JJ. Extension of time granted. Application for special leave to appeal granted.
- 16 September 2011 Appellant's notice of appeal filed.
- 23 September 2011 Respondent's notice of appearance and notice of contention filed.
