- 2. The Second Respondent (**Mr Wills**) supports the Appellants' notice of appeal dated 29 September 2023 and the Appellants' submissions in these proceedings dated 2 November 2023. Mr Wills does not seek to make further submissions in relation to the Appellants' appeal in this proceeding.
- 3. If the Court allows the appeal by the Appellants in these proceedings and concludes that there is no primary contravention, it follows that the finding that Mr Wills was knowingly concerned in the First Appellant's contravention must be set aside. This is the subject of Ground 3A of Mr Wills' proposed amended notice of appeal in Proceeding S116 of 2023.
