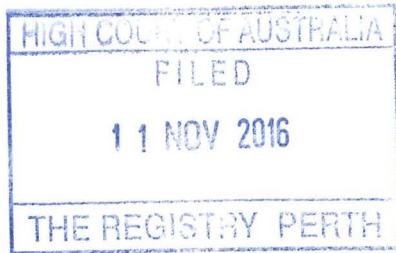

16.07.2012	Appellant was charged, in Perth, with one count of possession of MDMA with intent to sell or supply, and one count of possession of methylamphetamine with intent to sell or supply, contrary to s 6(1)(a) of the <i>Misuse of Drugs Act 1981</i> (WA).	CCA, [2]
26.09.2013	Appellant was found guilty of the offences that he was charged with by a verdict of 11 of the 12 jurors at his trial. The jury did not unanimously find the appellant guilty of the offences.	CCA, [133]
