
PART II CHRONOLOGY

Date	Event	Appeal book reference
4 December 2012	Today FM (Sydney) Pty Ltd (Today FM) recorded a prank phone call between two of its presenters and two hospital staff at King Edward VII Hospital in London, where the Duchess of Cambridge was an inpatient being treated for acute morning sickness (the Segment)	
4 December 2012	Today FM broadcast the Segment	
5 December 2012	Today FM broadcast the Segment again	
13 December 2012	The Australian Communications and Media Authority (the Authority) notified Today FM that it was conducting an investigation into the broadcast of the Segment under s 170 of the <i>Broadcasting Services Act 1992</i> (Cth)	
4 June 2013	The Authority provided Today FM with a copy of its preliminary investigation report (Preliminary Investigation Report No 2928)	
18 June 2013	Today FM commenced proceedings in the Federal Court of Australia	
7 November 2013	The Federal Court of Australia gave judgment, dismissing Today FM's application	
19 November 2013	Today FM appealed to the Full Court of the Federal Court of Australia	
20 February 2014	The Authority provided Today FM with a copy of its final investigation report (Investigation Report No 2928)	
14 March 2014	The Full Court of the Federal Court of Australia gave judgment, allowing Today FM's appeal	
11 April 2014	The Authority sought special leave to appeal to this Court	
15 August 2014	The Authority was granted special leave to appeal to this Court
