INITIATING PROCESS: Special Case / Consent



BY CONSENT THE COURT ORDERS THAT:

1. The parties have leave to file a special case jointly in this proceeding and in the proceeding *The Digital Freedom Project Incorporated v The Commonwealth of Australia & Ors* (S163/2025).
2. Pursuant to r 27.08.1 of the *High Court Rules 2004* (Cth), the questions of law stated by the parties in the special case be referred for the opinion of the Full Court.
3. The special case be heard concurrently with the special case in the proceeding *The Digital Freedom Project Incorporated v The Commonwealth of Australia & Ors* (S163/2025). The submissions referred to in orders 6 to 10 below are to be served on the plaintiff in that proceeding.
4. The matter be set down for a hearing of 2 days' duration on a date to be fixed in the November 2026 sittings.
5. On or before 4.00 pm on 14 August 2026, the plaintiff file and serve a special case book in accordance with an index settled by the Registrar.
6. On or before 4.00 pm on 28 August 2026, the plaintiff file and serve written submissions, not exceeding 20 pages, and a chronology.
7. On or before 4.00 pm on 11 September 2026, any interveners in support of the plaintiff file and serve written submissions, not exceeding 20 pages.

This Order was prepared in the Registry.

8. On or before 4.00 pm on 25 September 2026, the defendants file and serve written submissions, not exceeding 20 pages.
9. On or before 4.00 pm on 9 October 2026, any interveners in support of the defendants, or in support of neither party, file and serve written submissions, not exceeding 20 pages.
10. On or before 4.00 pm on 16 October 2026, the plaintiff file and serve written submissions in reply, not exceeding 5 pages.
11. There be a single joint book of authorities filed in both *The Digital Freedom Project Incorporated v The Commonwealth of Australia & Ors* (S163/2025) and *Reddit, Inc. v Commonwealth of Australia & Anor* (S166/2025).
12. On or before 12 noon on 23 October 2026, the plaintiff file and serve a joint book of authorities prepared in accordance with Practice Direction No 2 of 2024.
13. Unless otherwise ordered or directed, Part 44 of the *High Court Rules 2004* (Cth) relating to written and oral submissions apply, with any necessary adaption, to this proceeding.
14. The parties have liberty to apply on three days' written notice.
15. Costs be costs in the cause.
