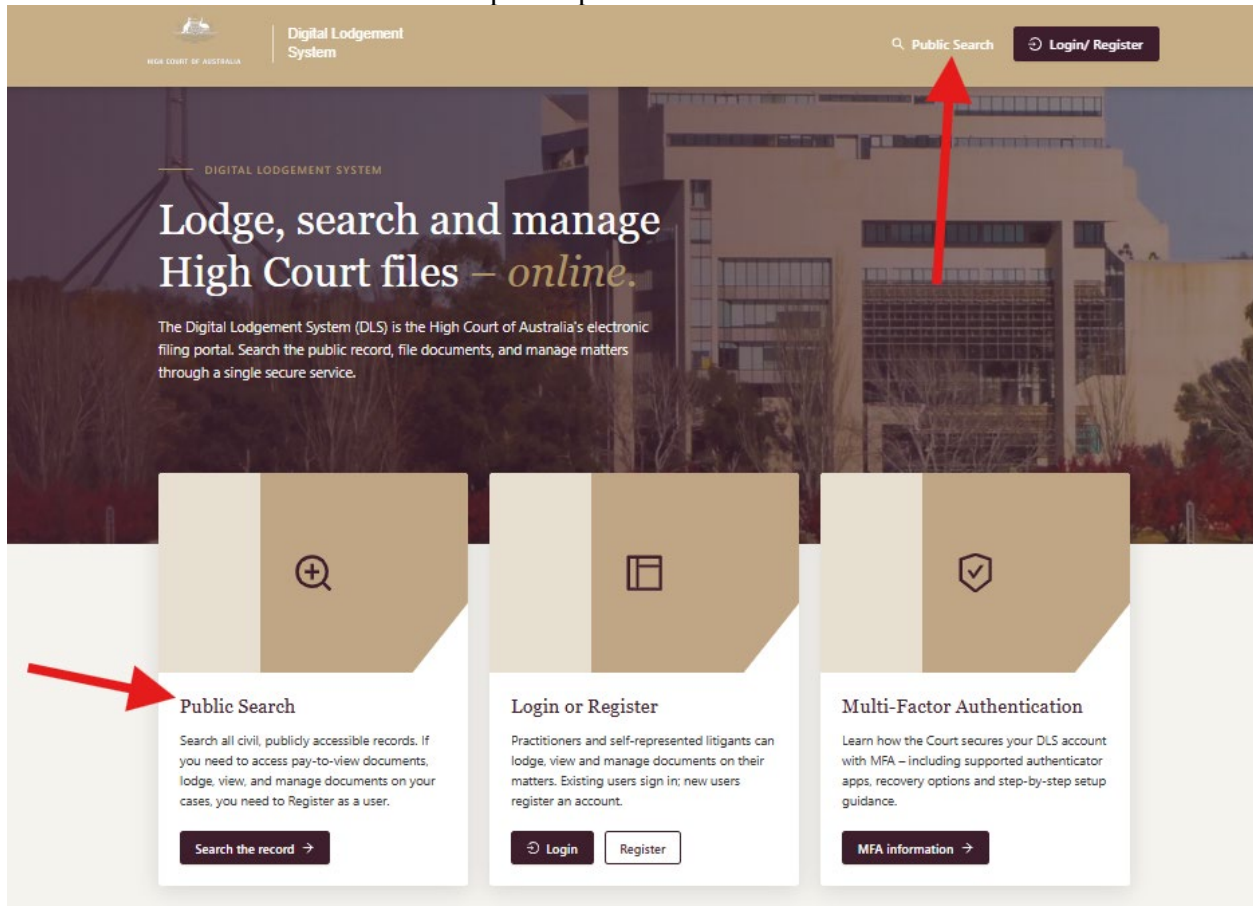




HIGH COURT OF AUSTRALIA

How to inspect a file or obtain copies of documents

Click on **Public Search** either on the public portal:



or within the DLS Portal if you are logged in:



Enter the search term you wish to use; this will return any results as a list.

NOTE: it is suggested that you use the simplest unique search string in order to return a meaningful results list. For example, searching on too many words will return a failure response error whereas searching on “and” will return thousands of results. Try using a party name or the case number.

If you are searching while logged into your account, you are not required to enter the reCAPTCHA.

There is a \$34.00 search fee to **Inspect** the file, which gives you access for 1 hour to all visible documents on the file. You will be asked if you wish to proceed to viewing the file. If you accept and continue, you will be asked to sign in and pay by credit card before access is granted:

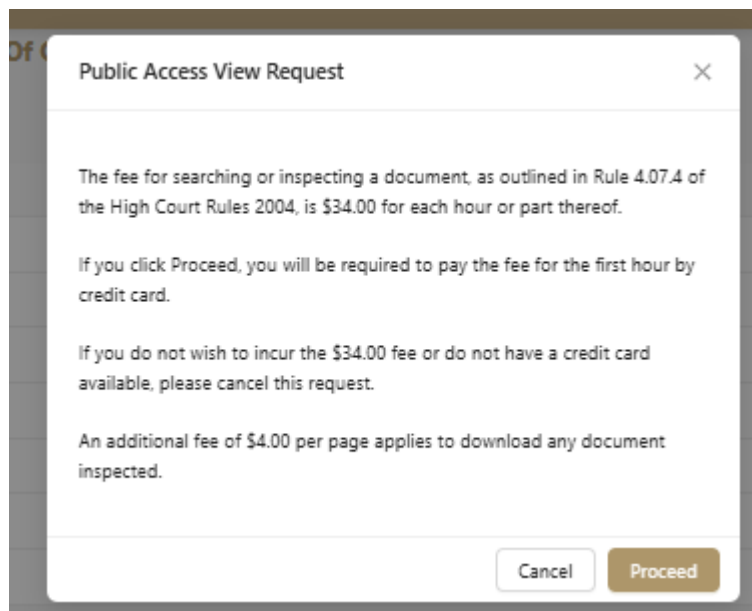

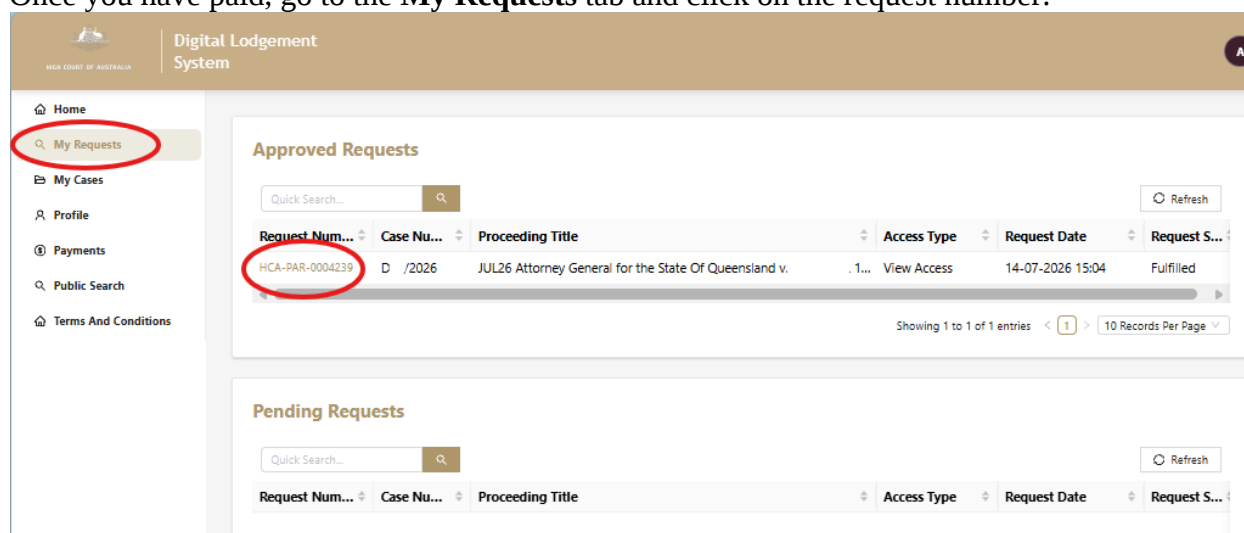

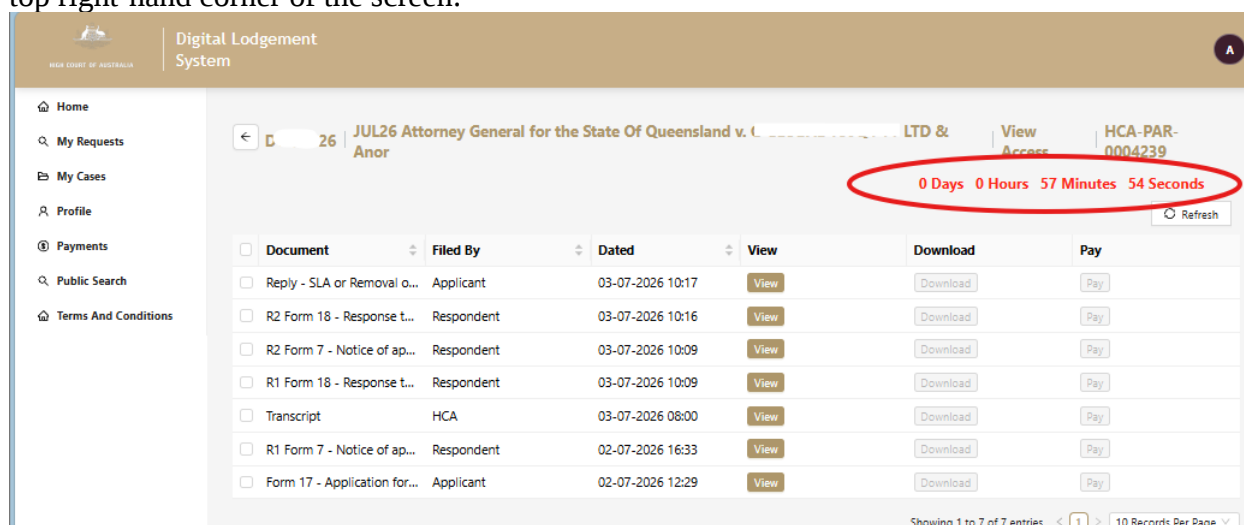

Once you have paid, go to the **My Requests** tab and click on the request number:

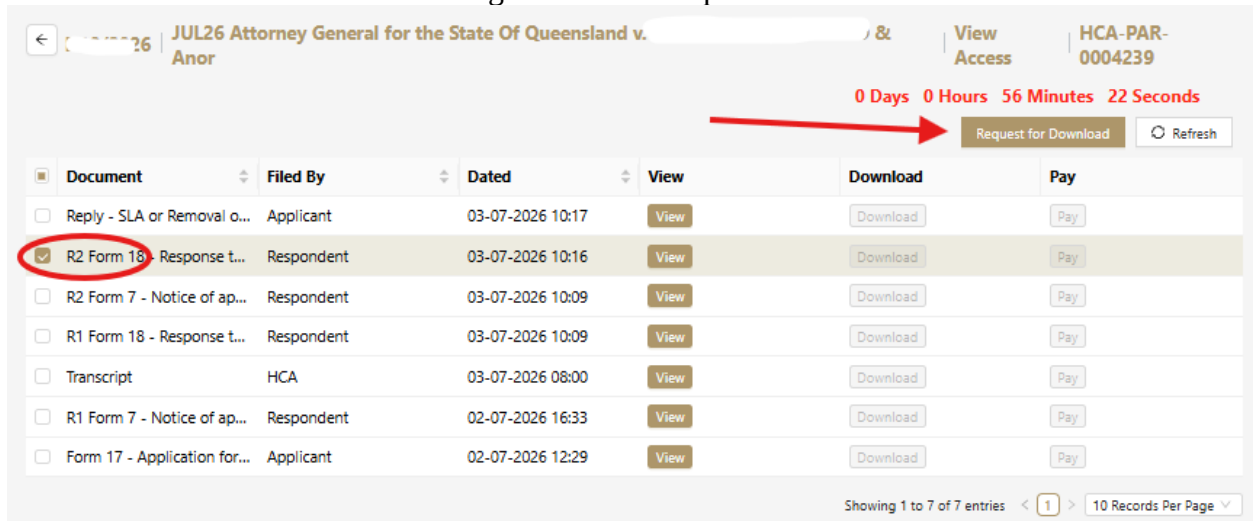


This will open the file and you will now be able to view the documents by clicking on the **View** button. The counter for the one hour commences when the payment is made and displays at the top right-hand corner of the screen:



Downloading a document

If you wish to download a document from the document list for that matter, click the box next to the document name and click the **Request for Download** button. You can request multiple documents from the same file in a single download request.



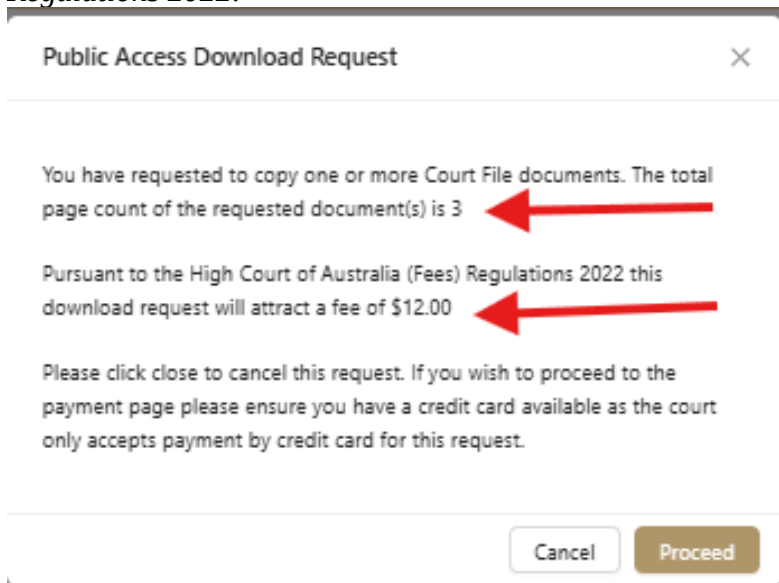

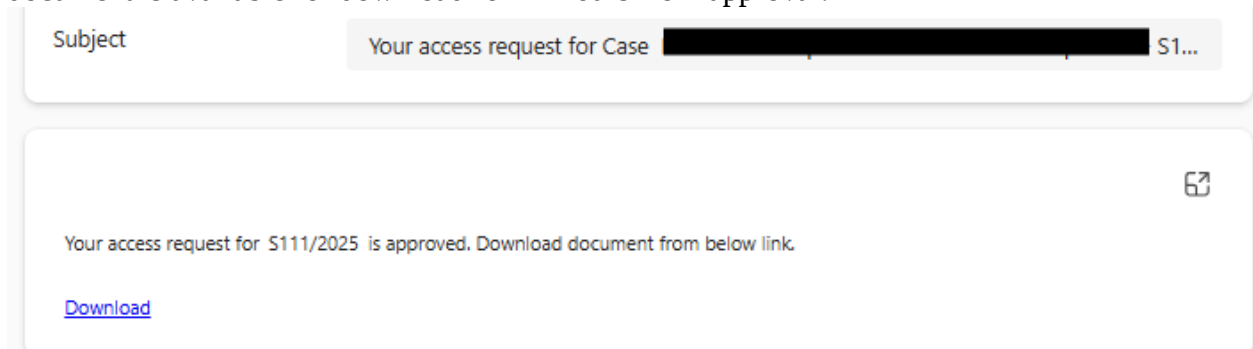
